

Value added by manufacture for 1939 on a basis comparable with the figures shown for earlier years was \$283.3 million for the State and \$82.8 million for the Atlanta Metropolitan Area. ⁴ The figures for 1935-47 exclude, whereas those for 1899-1933 include, data for "Railroad repair shops" and "Manufactured gas." Value added by manufacture for 1935, including data for these industries, was \$195.5 million. The comparability of the figures for 1899-1933 with those for later years is also affected to the extent that the following small industries, no longer classified as manufacturing, were represented in the State prior to the year shown in parentheses: "Peanuts and walnuts, processed or shelled" (1933), "Motion pictures" (1931), "Flax and hemp, dressed" (1931), and "Grindstones, pulpstones, and millstones" (1929).

⁵ The 1929 figures for the Atlanta Metropolitan Area could not be adjusted to exclude data for "Railroad repair shops," "Manufactured gas," and other industries no longer classified as manufacturing, and therefore they are not entirely comparable with the figures for later years. (See footnote ⁴.) Also, they are not entirely comparable with the figures for 1919 because of the inclusion of data for the "Automobile repairing" industry in that year.
