

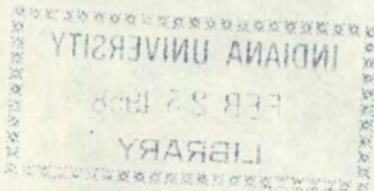

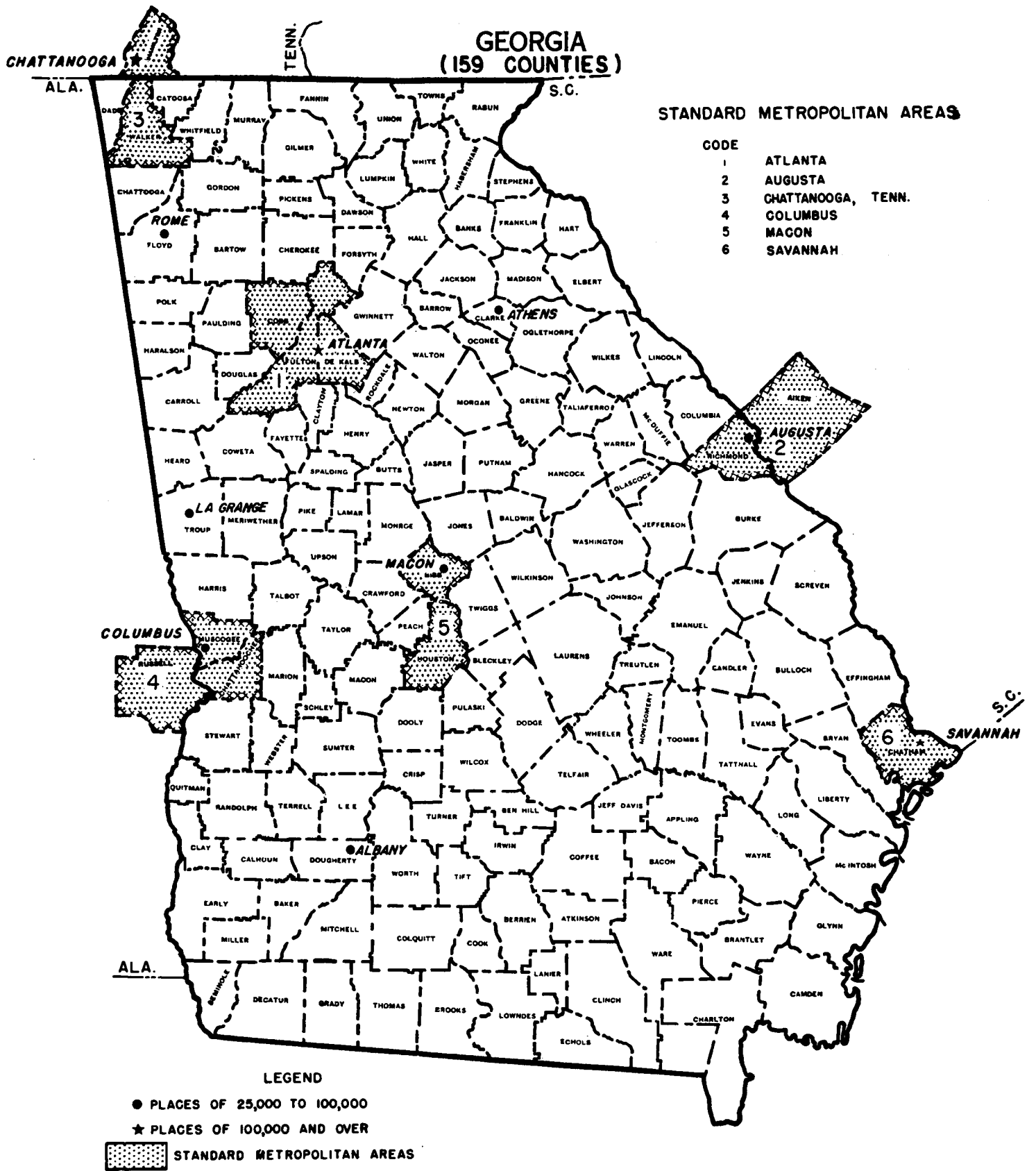

<sup>2</sup>The employment figures for operating manufacturing establishments for 1949-1953 are estimates derived from a representative sample of manufacturing establishments canvassed in the Annual Survey of Manufactures. These estimates, consequently, may differ from the results that would have been obtained from a complete canvass of all manufacturing establishments. The standard errors associated with these estimates are published in the Annual Survey of Manufactures volume for this period. The employment figures for administrative and auxiliary units were compiled chiefly from Bureau of Old-Age and Survivors Insurance records and are not strictly comparable with the figures for these units that were collected by the Bureau of the Census for the year 1954.

<sup>1</sup>The 1954 figures include data for establishments engaged in the processing and distribution of fluid milk, Industry Group 202, Dairy Products. These establishments were not included in the figures for the Annual Survey years 1949-1953 or earlier Census years. In addition, the 1954 Census and Annual Survey years include data for Logging camps and contractors, Industry 2411, which were not included within the scope of the 1947 Census. See footnotes to Table 4 for comparable 1954 and 1947 totals. There were also a number of changes in the definition of manufacturing industries during earlier Census years that affect the comparability of the historical series. Among the more important of these were: figures for 1935 and later years exclude data for "Railroad repair shops" and "Manufactured gas" which were included in 1899-1933 figures; the minimum size of establishment included for 1954 and 1947 was one employee, for 1939-1921 manufacturing establishments reporting value of shipments of \$5,000 or more were within scope whereas for 1919 and earlier years the cutoff was \$500. (This change in procedure has not appreciably affected the comparability of the historical data except for the figures on number of establishments.)
